ARTIST STATEMENT – DENNIS HARRISON

MARQUETRY IS AN ART FORM USING ONLY NATURAL AND DYED WOOD VENEERS IN THE PRESENTATION. A PIECE OF VENEER IS WOOD SLICED WITH A BLADE NOT CUT WITH A SAW BLADE TO A THICKNESS OF 1/28TH OR THINNER.

IT IS HUNDREDS OF YEARS OLD. ON THE EUROPEAN CONTINENT IT IS CONSIDERED A '*FINE ART*' AND COMPETES ONLY WITH OIL PAINTINGS.

EVERY MARQUETRY PICTURE IS TRULY ONE-OF-A-KIND; BEGINNING WITH THE INFINITE STRESSES PLACED IN A GROWING TREE TO THE FINAL SLICING OF THE VENEERS, EACH PIECE OF VENEER WILL NEVER BE DUPLICATED AGAIN. THERE IS NEVER A DROP OF PAINT ON ANY OF MY MARQUETRY.

I STARTED PRACTICING MARQUETRY IN THE TYPICAL MANNER, MOUNTAINS, CASTLES, AND RIVERS. I LOST INTEREST AFTER SEVERAL YEARS. THEN I ATTENDED A JAPANESE MATSURI. A GENTLE, CREATIVE PEOPLE IN ALL THEY DO. THE ART FORM OF FLOWER ARRANGING IN JAPAN IS CALLED IKEBANA. BUT IT IS MORE THAN AN ART FORM TO THE JAPANESE PEOPLE. IT REFLECTS THEIR SPIRIT AND WAY OF LIFE. I HAVE BEEN TRAINED AND I CURRENTLY HOLD A FIRST LEVEL CERTIFICATE IN THE SOGETSU SCHOOL OF IKEBANA OF JAPAN. I WORK USING MY MARQUETRY TO INFUSE THE SPIRIT OF IKEBANA INTO EACH MARQUETRY PIECE. I GAINED MY INSPIRATION FROM THE MATSURIS FOR MY MARQUETRY.

MY STUDIO IS IN RENTON, WASHINGTON

I GIVE EXHIBITIONS AND HANDS-ON CLASSES TO RAISE
PUBLIC AWARENESS OF THE ART.

THIS BOOKLET SUMMARIES MY TOTAL EXHIBITION HISTORY
INTO ONE VOLUME. IT FOLLOWS ROUGHLY A YEAR BY YEAR
ACCOUNT OF MY WORK.

ARTIST BIOGRAPHY

I WAS TRAINED AS A THEORETICAL MATHEMATICIAN. IT IS ALL IN THE DETAIL. OVER 55 YEARS, MY CHALLENGE HAS ALWAYS BEEN IN THE DETAILS AND BEAUTY TO INFUSE LIFE INTO MY MARQUETRY AS IT APPEARS IN MATHEMATICS. I LOOK FOR SCENES THAT CAN BE STYLIZED AND PRODUCE THE DESIRED EFFECTS USING ONLY WOOD. COUNTLESS HOURS ARE SPENT, LOOKING FOR JUST THAT ONE PIECE OF WOOD THAT HAS GROWN AND BEEN CUT JUST PRECISELY FOR MY PICTURE. IF THESE ESSENTIAL ELEMENTS DO NOT MEET MY STANDARDS, I WILL BEGIN THE PROJECT COMPLETELY ANEW; MARQUETRY ALLOWS FEW CORRECTIONS.

ALL ART EXHIBITIONS EITHER LOCAL, NATIONAL OR INTERNATIONAL USE A PAID, INDEPENDENT ART CRITIC TO DETERMINE (JUDGE) OR JURIES THE ART INTO THE EXHIBITION (SHOW) AND ANY AWARDS THEY WILL RECEIVE. THE COMMON WORD USED IS JURIED.

IN THE YEAR 2012, I WAS ENCOURAGED TO LOOK BEYOND THE LOCAL AND SOMEWHAT LIMITED REGIONAL EVENTS AND PURSUE A MORE NATIONAL EXHIBITION VENUE.

FROM 2015 THROUGH 2020 I TOOK A SABBATICAL FROM COMPETITION AND HELD CLASSES AND DEMONSTRATIONS IN THE WESTERN USA. I STARTED AGAIN IN MARQUETRY AND IN 2023, I WAS JURIED INTO EIGHT INTERNATIONAL. IN 2024 I WAS JURIED INTO EIGHT INTERNATIONAL AS OF JULY. I ALSO CONTINUE TO WORK IN THE FIELD OF WRITING A SERIES OF SHORT STORIES OF A FEMALE DETECTIVE IN SEATTLE WHICH IS NOW AT #108.

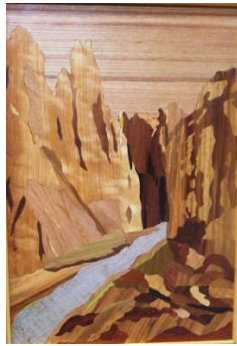

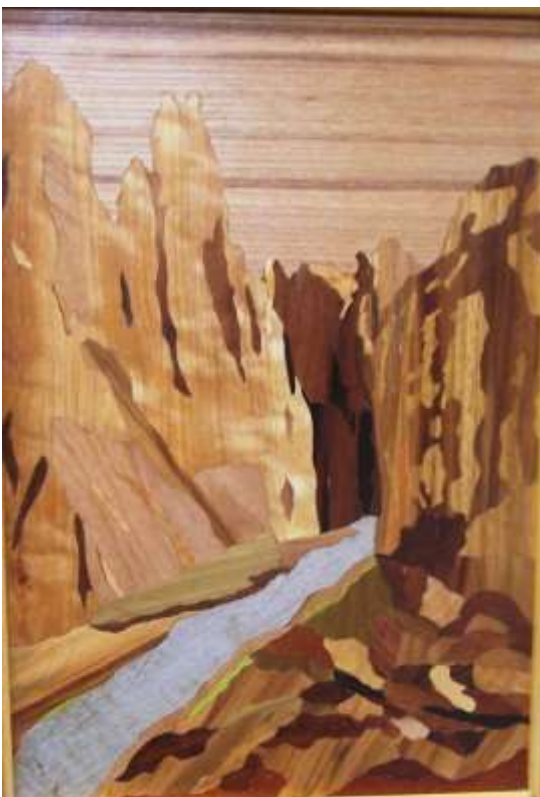

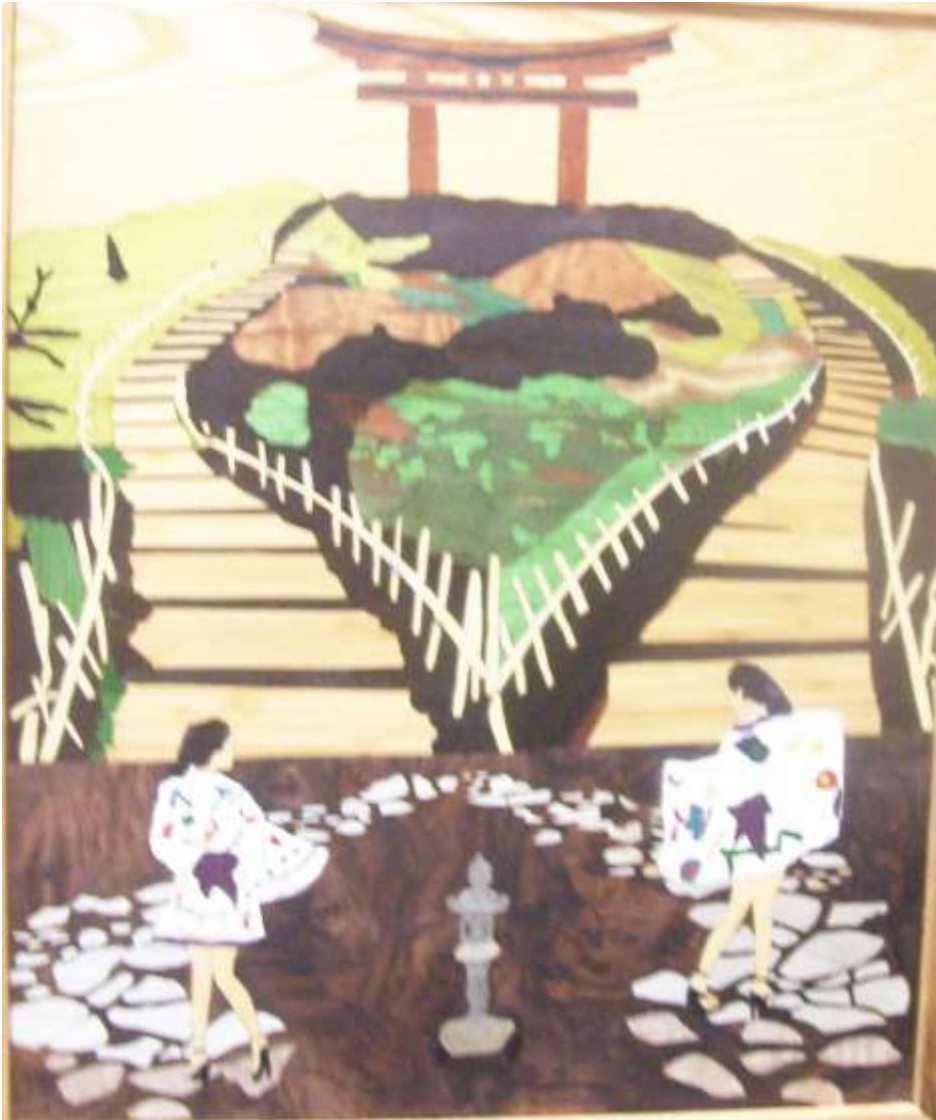
